PRIVACY POLICY IN THE CONTEXT OF USE OF THE KATCHA APPLICATION

This privacy policy sets out the conditions under which we will process personal data that we have collected about you or that you provide to us. Please read the following carefully to understand our position and practices with respect to your personal data and how we will manage them.

This is the Privacy Policy ("Privacy Policy") which governs how we, KATCHA (" we "," us "or" our ") use the personal data (defined below) that we collect, receive and store by means of: (i) the website www.katcha.io (the "Site"), (ii) the mobile application downloadable from

the apple store and the android store and (iii) the website www.katcha-app.com.

We do not host any sites. Hosting is provided by third party service providers that we hire.

This means that the data you transmit to us or that we collect (including data personal data, as defined below) - as described in this Privacy Policy -

are hosted with third-party service providers on servers they own or control. No matter the physical location where these third-party service providers are located, their servers can be located anywhere

in the world. Your data can even be replicated on multiple servers located in multiple countries. This Privacy Policy has been updated to ensure compliance with the General Regulations on data protection (General Data Protection Regulation: RGPD or General Data Protection Regulation or GDPR), which entered into force on May 25, 2018 and affects residents of the EU and Space

European Economic (EEA). Thus the processing designated in this Privacy Policy and Protection of Privacy are supported by a specific legal basis.

This Data Protection Policy aims to inform you of the rights and freedoms that you can assert with regard to our use of your personal data and describes the measures we take to protect them.

What personal information do we collect?

We collect your information when you subscribe or register on the Katcha Application or website Katcha. The Katcha company collects the Data that you voluntarily declare to it from a collection on the Site, in particular when you register as a User. This information is essential for creating your account. When you go to register you will be asked to enter: your email, last name, first name, gender, marital status, date of birth, nationality, language spoken, interests

personal or other similar information. We collect your transmitted data in order to be able to create a

customer account which is specific to you and which will allow you to use our services and participate in our events,

powered by the Katcha platform.

We also collect your information when you use our online services and participate in one of our events, hosted by the Katcha Application or by our Service Provider. When you use our services, the case

if applicable, you may be prompted to enter: your name, email, mailing address, phone number, interests

personal or other similar information. We also collect personal information during a event like, for example, your new connections, which parts of the event you liked the most and other. This is to help improve your experience during the event with recommendations.

Why do we collect this information?

Provide and maintain the Services

By using the information we collect, we are able to provide the Services to you and to honor the contract that binds you to our Service Provider. For example, we need to use your information to provide

the Katcha dashboard to our service provider which allows it to track your behavior, your activities and others

trends; to activate the community functions of the Services; and to provide you with all the information

useful during your stay with our Service Provider;

For community functions of the Services, we may use your information to help you find other users and connect with them and to allow other users to find and connect with you connect with you. For example, your account details allow other users to tell you add as katch. When your email address is in another user's directory or in their katch network on a connected service, we indicate to this user that you are also a user of our Services.

Improve, personalize and develop the Services

We also use the information we collect to maintain, protect and improve our services, perform data analyzes and tests; conduct research and surveys and develop new functions and new Services.

Communicate with you

We use your information when necessary to send you notifications relating to Services and respond to you when you contact us. We also use your information for you inform us of new functions or new activities or particular event that we believe may be to interest you. We may use your email address to notify you of our maintenances and you keep abreast of upcoming changes and improvements.

We may also use information collected from other technologies, such as "cookies" to improve your experience and the overall quality of our services. For more information, see our statement on the use of cookies.

How do we use your information?

We use the information collected to facilitate registration and your personal journey during your stay or participation in a defined event, as well as for the creation of your profile. During your stay or participation in a defined event, we use this information to provide you with recommendations in real time such as: activities and preferences personalized to your profile. We can also use this information for operational purposes such as: determining the maximum number of people registered

to an animation or event, the capacity of a room, a bus, reminders of the schedules if necessary and for

staff optimization. We also use the information collected to provide a record of your route in your personal journal. We may also share this information with third parties parties such as the event organizer and its partners to improve future events and you offer content tailored to your preferences.

How do we protect your information?

All information going to our servers is encrypted via Secure Socket Layer (SSL). We store and process your information on the servers hosted by OVH.

Third party integration

We may include third party products or services on our Application and web platform. These services have separate and independent privacy policies. So we have no responsibility for the content and activities of these sites. Nevertheless, we seek to protect the integrity of our products and

we invite all relevant comments about these services.

Termination

You can contact us at any time to remove any personally identifiable information on our databases and terminate your account. We undertake to process your request within 3 calendar days. You can contact us at postmaster@katcha-app.com or at the address at the end of this document.
